Stock inspectors prepared

State have refreshed their roles and responsibilities in the event of an emergency animal disease such as foot-and-mouth at workshops held in September.

NSW Department of Primary Industries regional veterinary officer Paul Freeman said the one-day workshops at Wollongbar and Tamworth covered identifying and reporting disease, implementing quarantines, and entering infected premises.

The inspectors were put through real life situations where they were required to use their powers under the NSW legislation.

The workshops are an important part of NSW preparedness in case of an emergency animal disease affecting the State's livestock industries. Similar workshops have also been staged at



Aquifer Interference Policy Released

THE State government recently released details of the Aquifer Interference and Strategic Regional Land Use Policies.

For the first time in the State's history, the NSW Government is protecting prime agricultural land and water resources while providing greater certainty for landholders and the resources industry.

The Strategic Regional land Use Policy comprises 27 new measures, including the Aquifer Interference Policy, provides greater protections for farmers and better balances

competing land uses.

These important policies were developed following lengthy consultation with farmers, land managers, communities, peak bodies

DPI played an important role in helping to shape these policies and balancing the land and water use requirements of our towns, farmers, industry and the environment.

NSW now has an Aquifer Interference Policy that objectively defines the process through which the DPI's NSW Office of Water will assess projects to determine any potential impact on the aquifer.

This policy is a key plank of the Strategic Regional Land Use Policy, delivery of which will involve the independent Office of Agricultural Sustainability and Food Security.

I thank all those stakeholder organisations, as well as DPI staff, for their contribution to the development of these new policies.

NSW Wild Dog Strategy Launched

I WAS pleased to recently launch the NSW Wild Dog Management Strategy 2012-2015. Wild dogs can devastate our livestock industries and are penetrating further and

further into our valuable grazing regions. The NSW government is determined to turn this around and, for the first time in NSW, has put in place a comprehensive strategy to better co-ordinate wild dog control measures.

The strategy details the roles and responsibilities of Government agencies, industry and the community and lists planning, surveillance, reporting and control actions to more effectively manage wild dogs.

I look forward to seeing more co-ordinated efforts to control wild dogs from these agencies.
