GP reports 08/09 - thank you to all who returned everything to me on time. Again there are certain LCAs/ LHPAs who I continue to chase for information. This is not only very frustrating but very time Riverina's reports were all submitted and received in Orange on time. It would have been nice to say all information submitted to me was of a high standard but it appears that the closer the deadline gets the fewer words appear on the questionnaires. Due to the sometimes lack of feedback submitted to me - some reports submitted to NWAC are very limited... so when we receive the funding announcements and if something doesn't get up - have a think about the lack of detail you may have put into your reports... would you found something that never achieves anything and people can't be bothered reporting about. I am pleased to report that N/A wasn't used to the extent it was in previous years reports (after I banned it's use) but there was still a general lack of detail the later the report was submitted.

Alligator weed – Riverina case study – Melissa freeman (NSW DPI) and I are in the process of compiling a regional case study for AW. This study will ensure consistency in the delivery of information relating to these infestations. We have so far received back some pretty valuable information – keep it coming....we've got a timeline already started for Woomargama and have also liaised with the property manager who'll fill in any gaps he can. Melissa will be meeting up with me in November to collate all the information prior to the next AW taskforce meeting. Hopefully we'll have something to circulate (draft) for comments before the end of the year.

Aquatic Weeds Advertising campaign – on air at present for 4 weeks! Looks fantastic and my daughter can now say "NSW has No Space for Weeds doesn't it mum"

Lachlan RWS – Draft finalised in June – no news as yet as to the printed doc... stay tuned.

Prioritising weed management for biodiversity conservation at the NRM level – NSW DPI and DECC project in conjunction with the CMAs. Workshops in the Murrumbidgee catchment next week – Wagga 14th and Hay 15th October.

Sagittaria Taskforce – endorsement of the strategy by WRNWAG & individual LCAs. Its declaration (lack of) in Victoria is holding up it's declaration as a target sp for Bio-

Serrated tussock – Box of CDs (resources), best practice guides etc – distributed to those in attendance.

WRM workshops – two workshops next week. Email to be sent advising which day to attend. It is necessary to attend the training so all weedos are equipped to review all class 4 weeds. The review is currently taking place and results need to be back with II NSW in February 2010.

Hawkweed – presentation at CSU Thurgoona on Friday (9th October) – "Hawkweeds – control eradication – case studies from New Zealand and Australia for managers". I will circulate all relevant information.

Noxious and Environmental Weed Control Handbook (4th edition) – is available from the II NSW bookshop. Electronic format is also available for download on their website.

RNWPO – Continuation of project (2010–2015). I have put together a realistic 5 year budget (Note: the current project has been running at a loss the past few years). I have also collated the past 6 year's expenditure statements into a summary. Both spreadsheets will be circulated, along with a


